I. Program Objectives

1. General Objectives

The doctoral training program in Civil Law and Civil Litigation of the University of Law Ho Chi Minh City aims to train a team of doctoral law scholars with deep and advanced knowledge in civil law, who are at the forefront of legal issues within the field of civil law, possess excellent scientific research methods, and can contribute to the development and improvement of Vietnamese law in the field of civil law.
